A. 01 12 00 - MULTIPLE CONTRACT SUMMARY

1. Incorporate the following revisions to the Multiple Contract Summary as noted below as part of Addendum 03.

I. BID CATEGORY NO. 09 - PAINTING

Add the following clarifications:

- 2. The Painting Contractor is responsible for preparing and painting ductwork and air devices as noted on the MV-11 & MV-21 Drawing Sheets. Specifically, reference Ventilation Plan Note #10 on Drawing MV-11 and Ventilation Plan Note #10 & #11 on Drawings MV-21. These surfaces shall be painted in conjunction with other painting operations in this area.
- 3. The Painting Contractor is responsible for preparing and painting exposed storm piping as noted on the P-12 Drawing Sheet. Specifically, reference Second Floor Plumbing Plan Note #12 on Drawing P-12. These surfaces shall be painted in conjunction with other painting operations in this area.
- 4. The Painting Contractor is responsible for painting the pipe insulation noted by HVAC Piping Plan Notes #P8 on Drawing MP-21. These surfaces shall be painted in conjunction with other painting operations in this area.

- 5. The Painting Contractor is responsible for painting exposed metallic electrical conduit. Paint color shall match the adjacent surface and be performed in conjunction with other painting operations in this area.
- 6. Exposed fire alarm and data cabling shall not be painting when painting other exposed areas or MEP work. Electrical Contractor to coordinate what specific cabling shall not be painted.

L. BID CATEGORY NO. 12 – PLUMBING & HVAC

Add the following clarification:

9. Painting of ductwork, air devices, exposed storm piping and piping insulation is by Painting Contractor. Reference Ventilation Plan Note #10 on Drawing MV-11 and Ventilation Plan Note #10 & #11 on Drawings MV-21. Reference HVAC Piping Plan Note #P8 on MP-21. Reference Second Floor Plumbing Plan Note #12 on Drawing P-12. Plumbing and HVAC Contractor shall notify Painting Contractor when rough-in is complete and ready for painting operations.

M. BID CATEGORY NO. 13 – ELECTRICAL & TECHNOLOGY

Add the following clarification:

13. Painting of exposed conduit is by Painting Contractor. Electrical Contractor shall notify Painting Contractor when rough-in is complete and ready for painting operations.
