CLARIFICATION

A NEW WATER SERVICE IS BEING BROUGHT IN FROM THE EAST.

BASE BID IS TO EXTEND THE FIRE PROTECTION JUST TO THE ADDITION AND EXISTING AREA C (SW CORNER OF THE EXISTING FACILITY) WITH A VARIANCE FOR NO HOSE ALLOWANCE. THIS WILL UTILIZE THE EXISTING 4" SERVICE WITHIN THE BUILDING.

OUTSIDE THE BUILDING, A NEW 6" LINE IS BEING BROUGHT IN FROM THE EAST. BASED ON THE FLOW TEST FROM THE ADJACENT SUBDIVISION, THE AVAILABLE FLOW AND RESIDUAL PRESSURE APPEAR TO BE VERY HEALTHY. THE ASSUMPTION IS THAT WHEN THE UTILITY EXTENDS THE NEW 6" IN THE STREET TO THE EAST, THIS WILL MAINTAIN SIMILAR FLOW CHARACTERISTICS AND PROVIDE THE BUILDING WITH GOOD FLOW AND PRESSURE.

THE ALTERNATE TO EXTEND THE FIRE PROTECTION TO THE REST OF THE BUILDING DOES NOT NEED TO INCLUDE UPDATING THE INTERIOR SERVICE FROM 4" TO 6" OR ADDING A PUMP BECAUSE OF THE HOSE ALLOWANCE VARIANCE. PRESSURES ARE GOOD AND FLOW IS STILL WITHIN THE BOUNDS OF WHAT A 4" SERVICE PROVIDES.
