

SCOPE OF WORK



- Replace damaged exterior wall, including replacement of footings, foundations, CMU, brick, DCMU, ductwork, electrical wiring, roof drains, roofing, slab-on-grade concrete, flooring, ceiling grid, sidewalks, and landscaping. Plans also include reinstalling classroom finishes like casework, ceiling tile, and lighting.
- Total Estimate = \$425,000+/-
- 890SF of Renovation
- Construction = December 2025 – April 2026


FIRST FLOOR DEMOLITION PLAN - RM 129








1 FIRST FLOOR PLAN - RM 129


