

ITEM NO. 1. DRAWING SHEET NO. E1.01

- . Remove lighting alternate from scope of work. Delete keynotes L1 through L3. Existing lighting fixtures and controls shall remain as-is.
  
- B. Delete fan control and plan notes P5 and P6 in their entirety. Owner has already installed three fans in existing room. Delete two northernmost receptacles and circuitry for fans, Owner has already installed these fans. Relocate southernmost fan to new location in expanded location, see architectural plans. Install Owner provided 20" fan and bracket similar to existing installation in new location, see architectural plans. Extend existing circuitry serving three fans as required for the relocated third fan and new fourth fan.
