PART 2 - PRODUCTS

2.01 MATERIALS

- B. Posts: Structural lumber with smooth faces for paint finish.
- C. Finish: Wood primer and enamel finish coat of paint as approved by Construction Manager.

PART 3 - EXECUTION

3.01 SIGNS

- A. Provide and maintain adequate signage to control construction traffic and site visitors.
 - 1. Text will be per the Skillman Corporation sign standards. Camera ready art and sign purchase is available through Reprographic Arts Signs at (219) 872-9111, if so desired.
 - 2. Remove signage when directed by Construction Manager.

3.02 CONTRACTOR SIGNS

- 3. Remove signage when directed by the Construction Manager.





GENERAL NOTES:

- Contractor shall comply with Town of Zionsville Ordinances. Noise ordinance hours: Town of Zionsville Noise Ordinance which establishes that noise shall not be made at any times other than between the hours of 7:00 a.m. and 7:00 p.m., Monday through Saturday.
- All Construction areas, including, but not limited to lay down and dumpster/equipment storage spaces areas shall be enclosed with fencing.
- All laydown areas and surfaces disturbed during performance of the Work need restored to match existing conditions. After restoring sod, maintain fencing to protect areas until all grass has grown back.

SCHEDULE NOTES:

(Reference Guideline Schedule).

- It is anticipated that door #4 will have high volumes of traffic throughout the summer. Activities of school operations in the summer include, but are not limited to, indoor and outdoor camps, athletic events, band and music events.
- Tennis Tournament: During Saturday, June 18, 2022, and Sunday June 19, 2022, school is hosting a Tennis Tournament in tennis courts south of the school. Contractor shall limit noise on these days to avoid disruption of event.
- July 1, 2022 Milestone: All laydown spaces or construction access/egress in the south of the building must be cleared from for school activities. Sequence 1 and Sequence 2 Re-Roof areas completed.
- Contractor shall provide necessary manpower to meet milestone dates.
- Contractor shall reference Milestone Dates in Section 01 32 00 "Schedule and Reports."

The following clarifications, amendments, additions, revisions, changes, and modifications change the original Contract Documents only in the amount and to the extent hereinafter specified in this Addendum.

NOTE: Bidders are responsible for becoming familiar with every item of this Addendum. (This includes miscellaneous items at the very end of this Addendum.)

RE: ALL BIDDERS

ITEM NO. 1. PROJECT MANUAL, SECTION 07 31 13 – ASPHALT SHINGLES

A. Add 1.5, A., 1., 4., as follows:

“4. Evaluation documents by the existing Roof Deck and Substrate Manufacturer showing requirements for substrate board installation, screw attachment pattern and other requirements to bring roof system into compliance with current Building Codes and new Warranty requirements.”

B. Add 1.7, H., as follows:

“H. Roof Deck and Substrate Assembly Manufacturer: Existing roof deck assembly manufacturer is Loadmaster, Duluth, Georgia.

1. Manufacturer shall evaluate existing engineering for the project and make recommendations for procedures to bring the reroofed assembly into compliance with current Code requirements for roofing installation and performance loads.
2. Code compliant screw attachment patterns and installation requirements shall be provided by the Manufacturer for installation of new layer of substrate board in order to re-establish the systems composite action meeting Code required load-carrying requirements.”
